Tax Advantages for Donors

**Your gift of securities to Hospice Huntsville entitles you to an official donation receipt for the full market value of your donation.**

Your gift of securities will result in an official donation receipt from a registered charity enabling you to claim a non-refundable income tax credit on your tax return. Any unused gifts may be carried forward for up to five years to be credited against income tax in those years. Whether you give cash or securities, Hospice Huntsville will end up with the full amount of your donation since our brokerage firm will assist us in transforming gifts into cash.

**You pay no tax on capital gains on publicly-traded securities donated to Hospice Huntsville.**

Effective May 2006, charitable donations of publicly listed securities to registered charities are exempt from capital gains taxation on gains triggered as a result of the gift. Thus, donating publicly listed securities directly to Hospice Huntsville today or in the future may allow you to avoid the tax on a capital gain you may have, maximizing your after-tax dollars available to you. You will only benefit from this tax measure if you gift shares that have an accrued capital gain.
